

FALCONER PUBLIC LIBRARY BOARD REPORT JANUARY 8, 2024 – FEBRUARY 12, 2023

The library board met on Thursday, January 18th. Chautauqua Cattaraugus Library System Director, Jan Dekoff joined us and shared helpful information about services the system has to offer to assist our board. We are working on filling our additional board seats and finalizing our summer band concerts. It was decided that we would not continue our entrance construction project with the contractor we were working with. The board will have a special meeting in February to discuss our options moving forward.

The Chautauqua Cattaraugus Library System presented a webinar on January 24th that reviewed details about completing the annual report to the state. The final report is due to the system February 16th. We are very thankful to Village Treasurer, Paula Spunaugle for providing the financial part of the report for us.

We shared another large print book deposit with Silver Tree Living. We do this outreach four to five times per year.

Culture Care Senior Living came to the library on February 8th. Representatives from Tanglewood Manor, Memory Garden, Frewsburg Rest Home, Comfort Today Adult Day Services and Spa and the Cottages on the Pond shared what they can offer seniors in our community.

We are celebrating National Library Lovers Month in February with a "Blind Date with a Book". The staff have pulled books, wrapped them up and added a page on the front that offers the genre and some brief clues as to what the book might be about. When the patron returns the book they "rate the date" by telling if they enjoyed the book or not and then they are entered into a drawing to win a gift card to PersNikkity Pies. This has been very well received with 50+ books going out in just the first week!





February 2024 ARPA Committee Report

The American Rescue Plan Act of 2021 included significant funding to help state and local governments recover economically from the COVID-19 pandemic. Nearly \$20 billion in State and Local Fiscal Recovery Funds (SLFRF) were allocated to non-entitlement units of local government (NEUs). The Village of Falconer's share of State and Local Fiscal Recovery Funds (SLFRF) was \$230,460.84. As of this month, the Village has obligated or expended \$162,109.11, or 70.34% of the available funding.



As mentioned in previous meetings, the SLFRF final rule issued by the U.S. Department of the Treasury states that **all funds must be obligated by December 31, 2024, and expended by December 31, 2026**. It is imperative that the Village adhere to both deadlines; any remaining funds unobligated or unexpended by those dates must be returned to the federal government.

An obligation goes beyond budgeting for an expense and is defined by the federal government as follows:



Obligation means an order placed for property and services and entering into contracts, subawards, and similar transactions that require payment. An obligation also means a requirement under federal law or regulation or provision of the award terms and conditions to which a recipient becomes subject as a result of receiving or expending funds.



Several projects identified in the committee's previous report have since been completed. Upgrades and repairs to Village buildings were paid for using SLFRF funds, while Community Building chimney repairs and new accounting software were covered by other revenue sources. Remaining items include:

Restoration of the Community Building Parapet and Other Repairs (Critical)

In May 2022, a report was submitted to the Village outlining deficiencies in the exterior of the Community Building. Excluding the chimney, the estimated cost to repair the building perimeter at that time was \$451,365.00. With increases in material and labor prices, the cost will likely be much higher.

A number of revenue sources will need to be identified to move forward with the project, including the Community Building reserve, sales tax revenue, grant opportunities, and the Village's fund balance. While those options are being explored, the Village could consider using SLFRF funds to hire an independent architectural/engineering firm with historical building experience to conduct an inspection of the building and provide the stamped plans that will be required for the building permit and bidding process. Additional funds could be set aside to cover a portion of the restoration work.

Local Development Corporation (LDC)

Currently, neither Falconer nor Ellicott have a non-profit arm through which they can apply for grant funding for business development, housing development, or other improvements. That is why the Village is seeking to partner with the Town of Ellicott to form the Falconer-East Ellicott Development Corporation which would be an organization to promote economic development in Falconer and eastern portions of Ellicott. The corporation would consist of a board of community volunteers and, eventually, an executive director with a common interest in promoting economic development and prosperity.

With an agreement in place, both municipalities would start the process of creating the 501(c)(3) by seeking approval from the State of New York. The Village had initially sought funding through its 2023 NY Forward grant application to pay for the legal fees associated with the creation of the LDC. With the State of New York deciding to fund other applications instead, the Village could choose to use SLFRF funds to advance the formation of the Falconer-East Ellicott Development Corporation.

Falconer Park Enhancements

A variety of projects were discussed, including the restoration of water service to the Rec Building, tree removal, pickleball court installation, new playground equipment, and bathroom renovations.

With less than a third of SLFRF funds remaining, it is also important to weigh all projects to prioritize pressing concerns and identify work that can be paid for using alternate revenue sources such as grant funding or support from community organizations. We look forward to discussing these and any other potential projects with the entire Board of Trustees during the upcoming 2024-25 Budget preparations.

TOWN OF ELLICOTT LOCAL LAW #1 of 2023
BEST VALUE COMPETITIVE BIDDING AND PROCUREMENT

Section 1. Title

This Local Law shall be known as the "Town of Ellicott Local Law #1 of 2023, a local law Authorizing Best Value Competitive Bidding and Procurement."

Section 2. Legislative Intent and Purpose

The Town Board seeks to exercise the local option set forth in § 103 of the General Municipal Law, which authorizes the Town to award purchase contracts and service contracts subject to competitive bidding under § 103 of the General Municipal Law on the basis of either the lowest responsible bidder or "best value", as defined in § 163 of the New York State Finance Law. This authorization provides the greatest measure of flexibility in the Town's public bidding procedures and ensures the best value and price for the residents of the Town of Ellicott.

Section 3. Authority

This local law is enacted pursuant to the New York Municipal Home Rule Law, as authorized pursuant to New York State General Municipal Law § 103 and the New York State Finance Law § 163 and any other provisions of law authorizing the Town of Ellicott to enter into contracts and engage in contracting for services.

Section 4. Best Value Competitive Bidding

A. Authority and Purpose.

Section 103 of the New York General Municipal Law allows the Town to authorize, by local law, the award of certain purchase contracts (including contracts for services) subject to competitive bidding under General Municipal Law § 103 on the basis of "best value" as defined in Section 163 of the New York State Finance Law. The "best value" option may be used if it is more cost-efficient over time to award the contract for goods or services to other than the lowest responsible bidder if factors such as lower cost of maintenance, durability, higher quality, and longer product life can be documented.

B. Award Based on Best Value.

The Town Board may award purchase contracts and service contracts that have been procured pursuant to competitive bidding under General Municipal Law § 103 by either the lowest responsible bidder or on the basis of "best value" as the term is defined in New York State Finance law § 163. All contracts or purchase orders awarded based on best-value bidding bases shall require Town Board approval.

C. Applicability.

The provisions of this local law apply to Town purchase contracts, including contracts for services, involving an expenditure of more than \$20,000, but excluding purchase contracts necessary for the completion of a public works contract pursuant to Article 8 of the New York Labor Law and any other contract that may in the future be excluded under state law from the best value option. If the dollar thresholds of New York General Municipal Law §103 are increased or decreased in the future by the State Legislature, the dollar thresholds set forth herein shall be superseded by such § 103, and this local law shall be read as if the numbers are amended to conform to said § 103.

D. Standard for Best Value.

1. Goods and services procured and awarded on the basis of best value are those that the Town Board determines to optimize quality, cost, and efficiency among responsive and responsible bidders, as set forth in the procurement policy of the Town, as time-to-time and hereafter amended by the Town Board.

2. Where possible the determination shall be based on an objective and quantifiable analysis of clearly described and documented criteria as they apply to the rating of bids or offers.

3. The criteria may include, but shall not be limited to, any or all of the following: cost of maintenance; proximity to the contractors; longer product life; product performance criteria; quality of craftsmanship.

E. Documentation.

Whenever any contract is awarded on the basis of best value instead of lowest responsible bidder, the basis for determining best value shall be thoroughly and accurately documented.

F. Piggybacking of purchases.

Notwithstanding the provisions of this Local Law, the Town of Ellicott may, for purposes of public purchases, utilize the provisions of General Municipal Law § 103 with regard to the so-called "piggybacking" of purchases. The Town of Ellicott may piggyback whenever allowed by law, including but not limited to the following situations and criteria:

1. Pursuant to General Municipal Law § 103 the Town of Ellicott may purchase through the bids solicited and bid lists generated by the United States government and New York State (and its political subdivisions and school districts) whenever such bids or bid lists are generated in a manner as complies with said § 103.

2. If not a bid or list generated by a New York State governmental body or agency, then whenever such contract or bid lists were let in a manner consistent with or materially equivalent to the requirements of the State of New York as reflected in the policy and language of said § 103.

3. The Town may also piggyback upon any contract or foreign bid or bid list specifically approved for piggybacking through the New York State Office of General Services, as well as foreign bids and bid lists (mainly, of sister states) that meet the above criteria for piggybacking as set forth in sections 4(F)(1) or 4(F)(2) of this local law, immediately above.

G. Procurement Policy Superseded Where Inconsistent.

Any inconsistent provision of the Town's procurement policy, as adopted prior to the effective date of this Local Law by resolution of the Town Board, or as amended thereafter, shall be deemed superseded by the provisions of this local law.

Section 5. Severability

If any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective Date

This local law shall take effect immediately

NOTICE IS HEREBY GIVEN that there has been presented to the Town Council of the Town of Ellicott, New York, Introductory Local Law Number One (1) for the year 2023. The Town Council of the Town of Ellicott seeks to exercise the local option set forth in § 103 of the General Municipal Law, which authorizes the Town to award purchase contracts and service contracts subject to competitive bidding under § 103 of the General Municipal Law on the basis of either the lowest responsible bidder or “best value”, as defined in § 163 of the New York State Finance Law. This authorization provides the greatest measure of flexibility in the Town’s public bidding procedures and ensures the best value and price for the residents of the Town of Ellicott.

The Chautauqua Lake Rowing Association (CLRA) board is writing to inquire about using the upstairs area for an indoor practice space with the High School Team. As an outdoor sport, our facilities are not equipped for indoor use, and the second-floor space in your building enables CLRA to work with our team during March. We are inquiring about using the indoor space from March 4th, 2024, through March 28th, 2024. Practices would run from 5:30 pm to 7:00 pm, and as a club, we would take 3 to 4 evenings, depending on the availability of the space. CLRA would like to bring in our rowing machines and other smaller equipment to keep at the facility.
