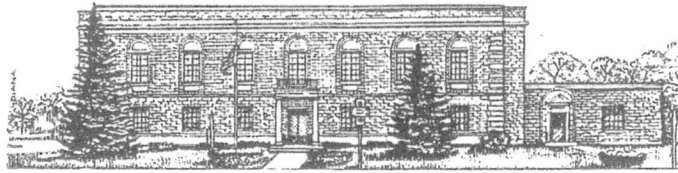

LEGAL NOTICE Notice of Public Hearing Village of Falconer

The Village of Falconer will hold a public hearing on July 8, 2024 at 6:00 pm at the Fireman's Exempt Hall, 101 West Main St., Falconer, NY 14733 for the purpose of hearing public comments on the Village of Falconer's community development needs, and to discuss the possible submission of one or more Community Development Block Grant (CDBG) applications for the 2024 program year.

The CDBG program is administered by the New York State Office of Community Renewal (OCR) and will make available to eligible local governments approximately \$100 million for the 2024 program year for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons. The hearing will provide further information about the CDBG program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the CDBG program or proposed project(s) will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

The Fireman's Exempt Hall is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation from English, those individuals should contact Cindy Capestrani, Clerk, at (716) 665-4400 at least one week in advance of the hearing date to allow for necessary arrangements. What Is It?

The New York State Office of Community Renewal Community Development Block Grant Program (CDBG) is a federally funded program authorized by Title I of the Housing and Community Development Act of 1974 that is administered by the Office for Community Renewal (OCR).

- The CDBG Program provides funding to eligible communities for the development of **projects that provide** (1) decent and hazard-free affordable **housing**, (2) access to safe **drinking water**, (3) proper **disposal of household wastewater**, (4) **access to community-needed services** in local facilities, (5) foster **microenterprise activities** and economic opportunities through the support of projects that create and/or retain permanent employment opportunities that principally benefit low-and moderate-income persons.
- In New York State, the application process is separated by the type of activity, with requests for grants to assist with Community Planning, Microenterprise, Public Facilities, and Public Infrastructure proposals falling under the Consolidated Funding Application that is awarded through the Western New York Regional Economic Development Council. Economic Development and Small Business Assistance applications are accepted year-round. Funding Opportunities for Housing activities for the state's 2024 funding allocation were announced May 13, 2024, with applications due July 31, 2024.

Activities funded under the CDBG Program must meet the **National Objectives** of (1) benefit low-and moderate- income persons, (2) aid in the prevention or elimination of slums or blight or (3) meet community development needs having a particular urgency.

Who can apply?

Cities/towns/villages with a population under 50,000 and counties with populations under 200,000 are eligible to apply

How much is available?

The total available for 2024 is approximately \$100 million for all eligible types of activities, including housing. The maximum funding limits are as follows:

Towns, Cities and Villages: \$750,000

Counties: \$1,500,000

What is the process?

The Village is seeking public input, especially from low-income residents, on whether to apply for CDBG funding under the 2024 funding allocation and, if so, what type of program to pursue. Again, eligible uses of CDBG funding include (1) decent and hazard-free affordable **housing**, (2) access to safe **drinking water**, (3) proper **disposal of household wastewater**, (4) **access to community-needed services** in local facilities, (5) foster **microenterprise activities** and economic opportunities through the support of projects that create and/or retain permanent employment opportunities that principally benefit low-and moderate-income persons. Citizen participation in the planning and implementation process is critical. There must be public interest in seeking funds and agreement on the proposed use of those funds.

The applications are extremely competitive and there is no guarantee that we will be successful, although we will prepare and submit the strongest proposal possible. Awards will probably be announced sometime in August or September and, if Falconer is awarded money, we would begin the program in late winter/early spring. Most construction would occur from Spring 2025 through the Fall 2026.

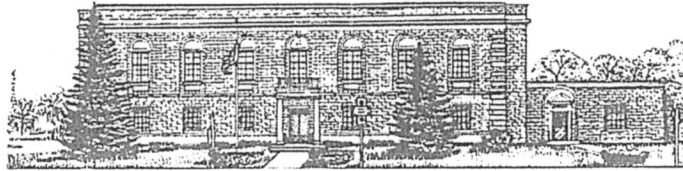

FALCONER PUBLIC LIBRARY BOARD REPORT JUNE 11, 2024 – JULY 8, 2024

The library board met on June 13th. It is their recommendation that we allow El Greco to complete our front door wood replacement, D&S Glass to replace the door and mechanics for handicapped door, Venable concrete will put in the book drop that will be provided by FPL. It was reported that the library received grants from Anderson Rosch, United Arts Appeal, Chautauqua Region Community Foundation, and Chautauqua Cattaraugus Library System. The next meeting is scheduled for August 1st at 8:00 am in the library.

We held our Summer Reading Kick-Off on Monday, July 1st. The theme for this year is "Adventure Begins at Your Library". The event brought in over 100 people! Those signing up received their reading calendar, a bag of chips and a glider. They were also given the chance to enter a drawing for passes to the Elevation Jump Park in Erie, PA. These were donated to us from the jump park. We had the Art Mobile from the Quick Center at St. Bonaventure. They made travel suitcases with those who signed up. Local authors, Terry Lyle, Judy Long and TJ Buck signed copies of their books. There were yard games and a poster to color on the front yard and many of the makerspace activities were used on the main floor. Our entire staff was present to help and we also had volunteers help us with the sign ups, the coloring activities and monitoring the games.

We are very grateful for the summer reading prize donations from Tops Friendly Markets, Wendy's, Burger King, Tim Hortons, Elevation Jump Park and Brian and Kay Nelson.

Summer band concerts are scheduled from 6:30 – 8:30 on July 11, 18, 25 and August 1st. We thank the DPW for their help with providing chairs and blocking off traffic for these events and the Falconer Fire Department for providing a place for us in their truck bay if there is inclement weather.

We have planned "Adventure Tuesday" activities to go with our summer reading theme. Our first one was making travel journals with Elizabeth Singer. We had 21 participate!

Ashley Nelson is providing library outreach to the summer recreation program by visiting once a week with activities.

The library also received five fishing poles along with hooks and bobbers and informational literature from the DEC to share with our patrons.

Community Building Garage Door Repair Committee Meeting

Wednesday, June 26, 2024

Attendees: Paul Capitano, Carl Caprino, Anthony Cavallaro, Avery Faulkner, Alan Gustafson Jr.

Following the discussion at the Board of Trustees regular meeting on June 10, 2024, the committee met to explore alternatives to repairing the garage door lentils on the Community Building addition. Were the doors to be removed, either by demolishing the structure or enclosing it and improving the façade, the DPW equipment currently stored in that space would need to be relocated.

To meet the DPW's current and future needs, it was suggested that a pole barn be constructed with an area of 40'x50' and a height to accommodate one or two 12'(w)x14'(h) doors. The structure would have a metal roof and metal siding as well as concrete flooring to ensure any equipment stored would not be damaged. In researching a building with those specifications, Superintendent Caprino determined that the cost for such a structure could potentially exceed \$100,000.

After reviewing the area, the committee made an initial determination that the most logical location for the structure would be to build it as an addition to the existing pole barn behind the DPW building. A benefit to this would be a potential reduction in the costs of materials, although some of those savings may be offset by the need for a new garage door on the north side of the building to account for the loss of the current door on the southern side.

At this time, the Board of Trustees should discuss if it makes sense for Village staff to continue exploring this project and develop an RFP by drafting a site plan and stamped architectural drawings. Due to the building's proximity to the Chadakoin River, a floodplain analysis would also need to be conducted.

Some additional considerations:

- Are there steps the Village could take to reduce the cost of the project (e.g. pre- and post-construction work undertaken by the DPW department)?
- If cost is an issue, could stone flooring be used for a year or two before laying concrete?
- Whether the addition at the Community Building is removed or enclosed, is there a commitment to develop the current garage space into offices and/or meeting areas? Plans had been drawn up during a previous administration but did not advance due to the cost.

An engineering/architectural firm will already be needed for the Community Building parapet, so it may be beneficial for the firm to examine the entire building for repairs and future improvements to guide these decisions. Not only would that help the Village better plan for multiple construction phases, it would also be cheaper to have one comprehensive report to work from rather than conducting multiple studies. It would also be wise to explore grant opportunities at this time.

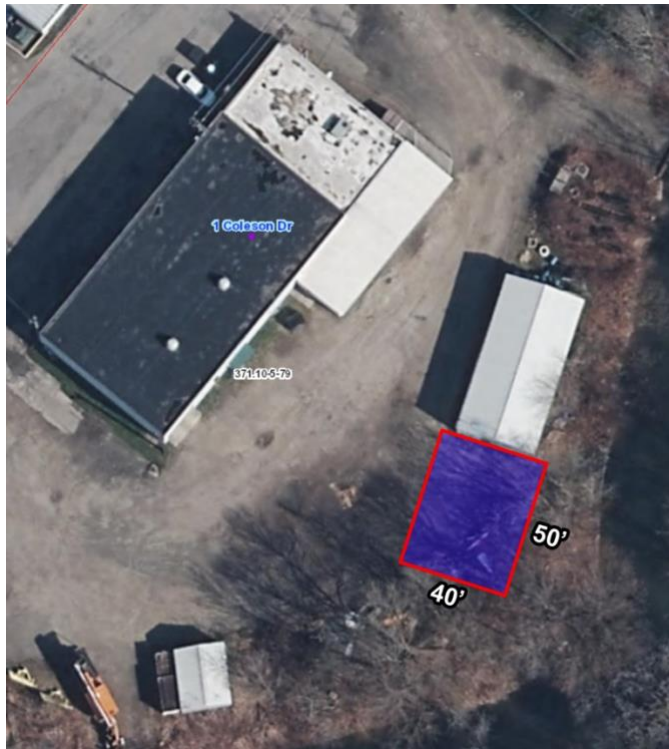


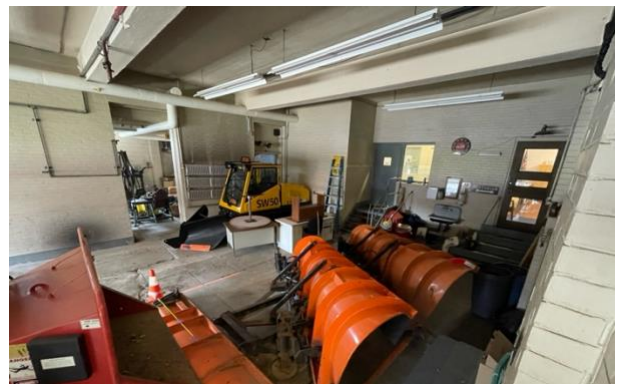
Figure 1 – Aerial photo of the DPW site with the proposed location for the new addition.



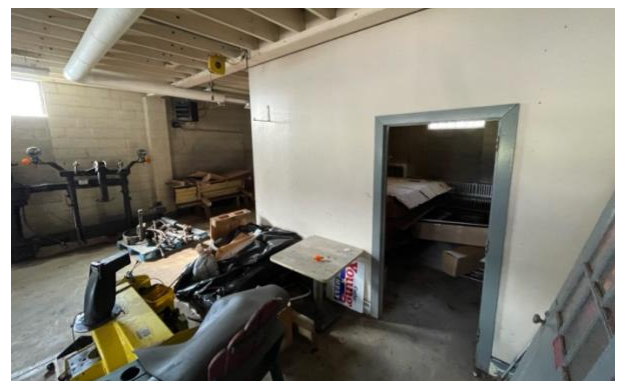
Figure 2 – Proposed location of the pole barn.

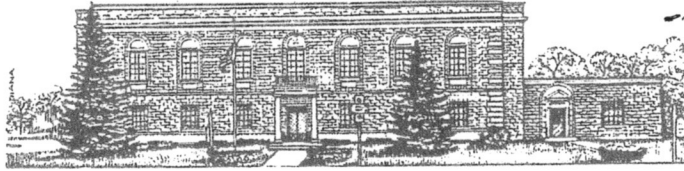


Figures 4 & 5 – The main garage bay at the Community Building.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE OF FALCONER, NY, that the Board of Trustees of the Village of Falconer adopts the Chautauqua County Multi-Jurisdictional Hazard Mitigation Plan, dated June 7, 2024. This plan, approved by the community, may be edited or amended after submission for review, but will not require the community to re-adopt any further iterations. This only applies to this specific plan and does not absolve the community from updating the plan in 5 years.
