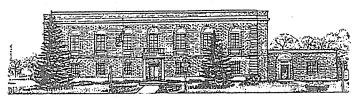

# Dog Control Report-October 2025 & Dog Control Calendar Yr. Summary Per Mayor Request

10/6 – Nina Gustafson called about dogs at 17 Mason. Stated one dog ran after/at them while walking on the road past the house. Also mentioned she thought they had 4 dogs there. I informed Nina that I have previously had complaints regarding their dogs and they have already been giving warning last month and that I would be issuing tickets this month.

**10/7** – Had calls all day about dog at 108 Falconer St. Also spoke to mayor about the dog. Dog is at large at that address and may need vet attention according to caller. I informed caller, village clerk and mayor that I was unavailable as I was at my day job and also that Humane Society still has me on a DO NOT BRING DOGS notice. According to my contract with the village I am not responsible for picking up dogs when the contracted shelter doesn't have room. If the dog needs vet attention then gets released I would have nowhere to take it. Also, as agreed upon in the past all legal responsibility falls on town of Ellicott to pick up dogs because they are the licensing municipality. I offered the town assistance in catching the dog but they never called me back.

**10/14** - Issued 2 tickets to 17 Mason. 30 day warning expired for unlicensed dogs and housing 4 dogs without a variance.

Calendar Year Summary Regarding Calls that were village dog law related: 4 calls that were documented on dog control reports. This doesn't include calls that have come in regarding people asking questions about the dog law or wanting to make an informal complaint and didn't want action taken with their name. This also doesn't include any calls that came in regarding dogs needing picked up due to those calls being forwarded to the town of Ellicott.
